Applying normative political philosophy to public policy issues, it addresses questions such as: What role, if any, should states play in supporting families? Should the state support national health care, and if so, why and in what form? What does society owe to the elderly? What role should welfare states play in supporting disabled people? What obligations does the state have toward the poor? As distinct from many works of political philosophy, *Justice Care and the Welfare State* draws on empirical data about the populations and circumstances of existing Western societies and offers concrete policy advice for reforming welfare policies.
